# Minutes of Authority Special Consultant/Vendor Committee Meeting March 19, 2019

#### **MINUTES**

### **REVIEW OF ORIGINATION AND SERVICER PROPOSALS AND REFERENCES**

Mr. Kitowicz stated that the meeting was called to review the references of the recommended service providers for origination and servicing. Mr. Kitowicz stated that the Committee wanted to discuss the references of the recommended origination and servicing providers. He gave the floor to Ms. Weldon.

Ms. Weldon gave an overview of the references for Campus Door.

1. InvestEd-Indiana has a three to four year old program which has originated \$5 million in 2018 and is on pace for \$7 million in 2019. They gave a strong recommendation citing Campus Door's responsiveness and updated platform.

- 2. UHEAA- Utah has been doing business with Campus Door for three years processing \$10 million annually. Their recommendation was mediocre stating that they have had issues with responsiveness and would grade them a B.
  - NHHELCO- New Hampshire also gave a mediocre recommendation and stated that they will no longer be partnering with Campus Door as they are moving to a platform that utilizes more in-house staff, as that is their business model.
- 3. Credit Union Service Organization (CUSO) is owned by 10 credit unions that makes its loan products available to 275 credit unions. They have partnered with Campus Door for 3 years and originate more than \$150 million annually and are very happy with the service they have received. This was a very positive recommendation.

Ms. Weldon stated the PNC Bank was not on the reference list provided by Campus Door but Mr. Hurlock had a personal contact at the bank. Mr. Hurlock gave an overview of his conversation with PNC Bank. They have partnered with Campus Door since January 2012 and originate \$140 million annually. PNC had a positive recommendation for Campus Door.

Ms. Weldon stated that Campus Door and UAS currently serve as the originator and servicer for CHESLA's Refi CT product and staff is satisfied with their services. Given that, and some of the positive references, staff remains comfortable with its recommendation to appoint Campus Door and UAS as originator and servicer. A discussion ensued on the implication of the references.

The Committee concluded it was satisfied with the reference check. No further action was required.

Mr. Kitowicz requested a motion to adjourn the meeting. Mr. Lisi moved to adjourn. Ms. Savino seconded the motion.
