2. The purpose of the call is to approve the recommendations of the 2% yield committee to temporarily reduce the interest rate on the 1996 loans from 8.1% to 0% and the 1998 loans from 7.5% to 2%. The attached letter would accompany a revised invoice to the borrowers who are either current at Firstmark or in collection with CCA within the two portfolios.
